EXECUTIVE COUNCIL CHAMBERS, VICTORIA MAR. 13 1975

RR Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) No person shall locate upon any of the lands within the following described area in the Alberni and Nanaimo Mining Divisions, Nootka, Rupert, Sayward, Clayoquot, and Comox Land Districts:

All that parcel or tract of land, together with all that land covered by water, more particularly described as follows:

Commencing at the northwest corner of Strathcona Park, thence easterly along the northerly boundary of said park to the easterly boundary of the watershed of Gold Lake, thence northerly, westerly, and southerly along the said easterly and northerly and westerly boundaries of the watershed of said Gold Lake to a point lying 100 chains more or less north 80° west of the natural boundary of the most westerly end of Gold Lake, thence south 10° east 150 chains more or less to a height of land, thence north 77° east 215 chains more or less to a point on the height of land on the southerly boundary of the watershed of Gold Lake, thence in a generally southeasterly direction along said boundary to the westerly boundary of Strathcona Park, thence northerly along said westerly boundary to the aforesaid northwest corner of Strathcona Park, being the point of commencement.

and

All that parcel or tract of land, together with all that land covered by water, more particularly described as follows:

Commencing at the southwest corner of Strathcona Park, thence northerly along the westerly boundary of said park 85 chains more or less to the northerly boundary of the watershed of an unnamed creek flowing into Moyeha Bay; thence westerly, southerly and easterly along the northerly, westerly and southerly boundaries of the watershed of said creek to the natural boundary of Moyeha Bay, thence in a general northerly direction along said natural boundary to the southerly boundary of said Strathcona Park, thence westerly along said boundary to the aforesaid southwest corner, being the point of commencement.

and

All that parcel or tract of land, together with all that land covered by water, more particularly described as follows:

Commencing at the southwest corner of Lot 748, being a point on the natural boundary of Great Central Lake on the northerly shore thereof, thence northerly and easterly along the westerly and northerly boundaries of said Lot 748 to the easterly boundary of the watershed of Drinkwater Creek, thence northeasterly along said easterly boundary to the southern boundary of Strathcona Park, thence westerly along said park boundary to the westerly boundary of the watershed of said Drinkwater Creek; thence in a general southeasterly direction along said boundary to a point on the natural boundary of Great Central Lake, thence in a general easterly direction along said natural boundary to the aforesaid southwest corner of Lot 748, being the point of commencement.

and

All that parcel or tract of land, together with all that land covered by water, more particularly described as follows:

Commencing at the southeast corner of Block 126, being a point on the westerly boundary of the Esquimalt and Nanaimo Railway Land Grant, thence northerly along the easterly boundary of said Block 126 to the southerly boundary of Block 1012, thence easterly, northerly, westerly, southerly, easterly, southerly, easterly, southerly, easterly, southerly and westerly along the southerly, easterly, northerly, and westerly boundaries of said Block 1012 to the natural boundary of Buttle Lake on the easterly shore thereof, thence northerly along the said natural boundary of Buttle Lake and the natural boundary of Upper Campbell Lake on the easterly shore thereof to the northerly boundary of that part of Block 121 lying to the east of said Buttle and Upper Campbell Lakes, thence easterly 82 chains more or less along said boundary and beyond to the easterly boundary of the watershed of said Upper Campbell Lake, thence in a general southeasterly direction along the said boundary and the easterly boundary of the watershed of said Buttle Lake to the aforesaid westerly boundary of the Esquimalt and Nanaimo Railway Land Grant, thence northwesterly along said boundary to the aforesaid southeast corner of Block 126, being the point of commencement.

and

All that parcel or tract of land together with all that land covered by water, more particularly described as follows:

Commencing at the point of intersection of the westerly boundary of the Esquimalt and Nanaimo Railway Land Grant and the natural boundary of Buttle Lake, on the westerly shore thereof, thence northwesterly along said Land Grant boundary to the natural boundary of Upper Campbell Lake on the southerly shore thereof, thence in a general easterly and southerly direction along said natural boundary of Upper Campbell Lake and the natural boundary of Buttle Lake on the westerly shore thereof to the northwest corner of Block 122, thence southerly and easterly along the westerly and southerly boundaries of said Block 122 to the said natural boundary of Buttle Lake, thence southerly along said natural boundary to the northeast corner of Block 123, thence westerly, southerly, and easterly along the northerly, westerly, and southerly boundaries of said Block 123 to the said natural boundary of Buttle Lake, thence southerly along said natural boundary to the aforesaid westerly boundary of the Esquimalt and Nanaimo Railway Land Grant, being the point of commencement.

and

All that parcel or tract of land together with all that land covered by water, more particularly described as follows:


Commencing at the point of intersection of the westerly boundary of the Esquimalt and Nanaimo Railway Land Grant and the natural boundary of Upper Campbell Lake on the northerly shore thereof, thence northwesterly and easterly along said Land Grant boundary to a point 70 chains more or less west of the natural boundary of Upper Campbell Lake and the westerly shore thereof, being a point on the easterly boundary of the watershed of an unnamed creek flowing southerly into Upper Campbell Lake, thence southeasterly along said watershed to the natural boundary of said Upper Campbell Lake on the westerly shore thereof, thence in a general westerly direction along said natural boundary of Upper Campbell Lake to the aforesaid westerly boundary of the Esquimalt and Nanaimo Railway Land Grant, being the point of commencement.

and

- (2) Upon the expiry of the term or cancellation of any existing mineral claim, placer claim or lease, or lease issued under the Mineral Act or upon the reversion to the Crown in the right of

the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no person shall locate upon such lands.
