SCHEDULE "A"

All unalienated and unencumbered Crown land situated in Cassiar District, more particularly described as follows:

Commencing at a point where the easterly boundary of Lot 4014 intersects the natural boundary of the Tseax River on the right bank thereof; thence northerly and westerly along the right bank of Tseax River to the natural boundary of the Nass River, on the left bank thereof; thence in a generally southerly and westerly direction along the said natural boundary of the Nass River to the easterly boundary of "Quinogag" Indian Reserve #61 (Lot 5287); thence southerly and westerly following the easterly and southerly boundaries of said "Quinogag" Indian Reserve #61 (Lot 5287) to the natural boundary of the Nass River, on the left bank thereof; thence in a generally southerly and westerly direction along the natural boundary of the Nass River to the easterly boundary of "Amatal" Indian Reserve #6; thence southerly and westerly along the easterly and southerly boundaries of said "Amatal" Indian Reserve #6 to the easterly boundary of "Amaral" Indian Reserve #46 and 47 (Lot 1094); thence southerly and westerly following the easterly and southerly boundaries of said "Amaral" Indian Reserve #46 and 47 (Lot 1094) to the natural boundary of the Nass River, on the left bank thereof; thence in a generally southerly and westerly direction along the said natural boundary of the Nass River to the easterly boundary of "Kitwilluchsilt" Indian Reserve #7; thence southerly and westerly along the easterly boundary of said "Kitwilluchsilt" Indian Reserve #7, and the easterly and southerly boundaries of "Gwinaha" Indian Reserve #44 (Lot 1093), and "Zaulzap" Indian Reserve #29 to a point where the southerly boundary of said "Zaulzap" Indian Reserve #29 intersects the right bank of Zolzap Creek; thence in a general easterly direction along the right bank of Zolzap Creek to the point of intersection with the 200 foot contour line; thence in a general northeasterly direction along the said 200 foot contour line to the right bank of an unnamed creek, said point being 13,000 feet more or less south of the northeast corner of "Samklksgamal" Indian Reserve #80 (Lot 5306); thence in a general northerly direction along the right bank of said unnamed creek to a point 12,200 feet more or less due west of the northwest corner of Lot 4013; thence N 85° E to the right bank of Vetter Creek; thence in a general southeasterly direction along the right bank of Vetter Creek to a point 4900 feet more or less S 84° 30' 00" W of the southwest corner of Lot 4013; thence S 45° 30' 00" E 6300 feet more or less to a point 2900 feet N 41° 00' 00" W of triangulation station Vetter; thence S 82° 00' 00" E 4800 feet more or less to a point 2900 feet N 63° 00' 00" E of triangulation station Vetter; thence S 72° E 1700 feet more or less to a height of land; thence S 66° E to a point, being the height of land 3300 feet more or less S 66° 30' W of the southeast corner of Lot 4014; thence S 38° E 3350 feet more or less to a height of land;

thence S 21° E 2900 feet more or less to a height of land; thence S 30° E 2750 feet more or less to a height of land; thence S 33° E 3700 feet more or less to a height of land; thence S 16° E 5500 feet more or less to a height of land; thence S 21° E 4400 feet more or less to a height of land; thence S 19° W 1800 feet more or less to a height of land; thence due south to the natural boundary of Lava Lake on the westerly shore thereof; thence in a northeasterly direction 300 feet more or less in a straight line to the intersection of the right bank of an unnamed creek with the natural boundary of Lava Lake on the easterly shore thereof; thence N 71° E 11,200 feet more or less to the middle line of an unnamed creek flowing in a northwesterly direction; thence N 52° E 12,500 feet; thence N 45° W 2900 feet more or less to the right bank of an unnamed creek flowing in a southwesterly direction; thence S 55° W 4900 feet more or less to the middle line of an unnamed creek flowing in a southerly direction; thence S 53° W 7900 feet more or less to a height of land; thence S 76° W to a point 4400 feet more or less N 42° 30' E of the point where the left bank of the Tseax River intersects the natural boundary of Lava Lake on the northerly shore thereof; thence N 1° W 4300 feet more or less to a height of land 600 feet due east of the natural boundary of Ross Lake on the easterly shore thereof; thence N 14° W 6700 feet more or less to a height of land; thence N 38° W 1700 feet more or less to a height of land; thence N 22° W 3800 feet more or less to a height of land; thence N 31° W 2200 feet more or less to a height of land; thence N 40° W 1300 feet more or less to a height of land; thence N 10° W 2800 feet to a height of land; thence N 28° W 5700 feet more or less to a point on the easterly boundary of Lot 4014; thence southerly along the easterly boundary of said Lot 4014 to the aforesaid point where the easterly boundary of said Lot 4014 intersects the natural boundary of the Tseax River, on the right bank thereof, being the point of commencement.
