EXECUTIVE COUNCIL CHAMBERS, VICTORIA JUL. 17 1975

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that with respect to the Mineral Act:

- (1) no person shall locate upon any of the lands within the following described area in the Kamloops Mining Division, Kamloops Division of Yale Land District:

South-east quarter of Section 33 Township 17, Range 21 West of the 6th Meridian;

and

- (2) upon the expiry of the term or cancellation of any existing mineral claim or lease issued under the Mineral Act or upon the reversion to the Crown in the right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon expiry or cancellation or reversion become subject to this order and no person shall locate upon such lands.

and further orders that with respect to the Placer Mining Act:

- (1) no free miner shall stake or acquire a location upon any of the lands within the following described area in the Kamloops Mining Division, Kamloops Division of Yale Land District, hereby designated as placer reserves:

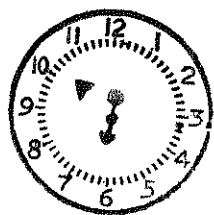
South-east quarter of Section 33 Township 17, Range 21 West of the 6th Meridian;

and

- (2) upon the expiry of the term or cancellation of any existing placer claim or lease issued under the Placer Mining or Placer-mining Acts the lands formerly contained in these instruments which fall within the above area shall immediately upon expiry or cancellation become subject to this order and no free miner shall stake or acquire a location upon such lands.
