



This is Schedule "A" which forms part of Order in Council No. \_\_\_\_\_

All those parcels or tracts of land and bodies of water situated in the Anstey Arm area of Shuswap Lake, Kamloops Division of Yale District, more particularly described as follows:

Commencing at the northeast corner of Fractional Section 18, Township 24, Range 7, West of the 6th Meridian, being a point on the natural boundary of Anstey Arm, Shuswap Lake, on the westerly shore thereof; thence westerly 1.2 chains along the northerly boundary of said Fractional Section 18, Township 24, Range 7, West of the 6th Meridian; thence due north 20 chains; thence due east 20 chains; thence due north to the westerly boundary of the watershed of Anstey Arm, Shuswap Lake; thence in a generally easterly and northerly direction along the westerly boundaries of the watersheds of Anstey Arm, Shuswap Lake, Hunakwa Creek and Hunakwa Lake to the northerly boundary of the south half of Section 9, Township 26, Range 7, West of the 6th Meridian; thence easterly along the said northerly boundary of the south half of Section 9, Township 26, Range 7, West of the 6th Meridian to the northeast corner thereof; thence due east to the westerly boundary of the watershed of Anstey River; thence in a generally northerly direction along the said westerly boundary of the watershed of Anstey River to the westerly boundary of the watershed of Mosquito Creek; thence in a generally northerly direction along the said westerly boundary of the watershed of Mosquito Creek to the  $51^{\circ} 20' 00''$  parallel of north latitude; thence easterly along the said  $51^{\circ} 20' 00''$  parallel of north latitude to the westerly boundary of the watershed of Myoff Creek being also a point on the easterly boundary of the watershed of an unnamed creek draining northeasterly into said Myoff Creek; thence due south to the easterly boundary of the watershed of Anstey River; thence in a generally southerly direction along the easterly boundary of the watershed of Anstey River to the northerly boundary of the watershed of Four Mile Creek; thence in a generally southerly, westerly and southerly direction along the said northerly boundary of the watershed of Four Mile Creek to the northerly boundary of the watershed of Queest Creek; thence in a generally westerly direction along the said northerly boundary of the watershed of Queest Creek to the easterly boundary of the watershed of Pete Creek; thence in a generally northerly direction along the said easterly boundary of the watershed of Pete Creek to a point due east of the northeast corner of Block B of the Northeast quarter of Section 17, Township 24, Range 7, West of the 6th Meridian; thence due west to the said northeast corner of Block B of the Northeast quarter of Section 17, Township 24, Range 7, West of the 6th Meridian; thence westerly along the northerly boundary of said Block B of the Northeast quarter of Section 17, Township 24, Range 7, West of the 6th Meridian to the natural boundary of Anstey Arm, Shuswap Lake, on the easterly shore thereof; thence in a generally northerly, westerly and southerly direction along the said natural boundary of Anstey Arm, Shuswap Lake, to the aforesaid northeast corner of Fractional Section 18, Township 24, Range 7, West of the 6th Meridian, being the point of commencement, and containing 95,550 acres, more or less.
