EXECUTIVE COUNCIL CHAMBERS, VICTORIA JUL. 31 1975

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) no person shall locate upon and no free miner shall stake on any of the lands within the area described in Schedule "A" attached hereto and made a part hereof which lands are situated in the Slocan Mining Division, Kootenay Land District during the period commencing on the date this Order comes into force and terminating on July 31, 1976;
- (2) upon the expiry of the term or cancellation of any existing mineral claim, placer claim or lease, or lease issued under the Mineral Act or upon the reversion to the Crown in the right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no person shall locate upon and no free miner shall stake on such lands;
- and
- (3) with respect to the Placer Mining Act the lands described in Schedule "A" above are hereby designated as placer reserves.

Commencing at the northeast corner of Lot 9300, said corner being a point on the natural boundary of Slocan Lake; thence westerly along the northerly boundary of Lot 9300 to the northwest corner thereof; thence due west to a point on the northerly watershed boundary of Wee Sandy Creek; thence westerly along said northerly watershed boundary of Wee Sandy Creek to the intersection of the westerly watershed boundary of Slocan Lake; thence southerly along said watershed boundary of Slocan Lake to a point on the watershed boundary of Gwillim Creek; thence southerly and easterly along the westerly and southerly watershed boundary of Gwillim Creek to the intersection of the watershed boundary of Mulvey Creek; thence southerly and easterly along the westerly and southerly watershed boundary of Mulvey Creek to a point due north of the northwest corner of Lot 3818; thence due south to said northwest corner of Lot 3818; thence easterly along the northerly boundary of said Lot 3818 to the northeast corner thereof, said corner being a point on the westerly boundary of Lot 14252; thence northerly along said westerly boundary of Lot 14252 to the southwest corner of Lot 14253; thence northerly and easterly along the westerly and northerly boundaries of said Lot 14253 to the northeast corner thereof, said corner being a point on the westerly boundary of Lot 3814; thence northerly and easterly along the westerly and northerly boundaries of said Lot 3814, to the northeast corner of Lot 3814; thence easterly along the northerly boundary of Lot 3813 to the southwest corner of Lot 3812; thence northerly along the westerly boundary of said Lot 3812 to the southwest corner of Lot 8859; thence northerly and easterly along the westerly and northerly boundaries of said Lot 8859 to the northeast corner thereof, said corner being a point on the westerly boundary of Lot 381; thence northerly and easterly along the westerly and northerly boundaries of said Lot 381 to the southwest corner of Lot 1531; thence northerly along the westerly boundary of Lot 1531 to the southwest corner of Lot 1532; thence northerly and easterly along the westerly and northerly boundaries of said Lot 1532 to the northeast corner thereof, said corner being a point on the natural boundary of Slocan Lake; thence northerly along the natural boundary of Slocan Lake to the southeast corner of Lot 10396; thence westerly, northerly and easterly along the southerly, westerly and northerly boundaries of said Lot 10396 to the northeast corner thereof, said corner being a point on the natural boundary of Slocan Lake; thence northerly along said natural boundary of Slocan Lake to the southeast corner of Lot 8223; thence westerly, northerly, and easterly along the southerly, westerly and northerly boundaries of Lot 8223, to the most northeasterly northeast corner thereof, said corner being a point on the natural boundary of Slocan Lake; thence northerly along said natural boundary of Slocan Lake to the southeast corner of Lot 6521; thence westerly, northerly and easterly along the southerly, westerly and northerly boundaries of Lot 6521 to the northeast corner thereof, said corner being a point on the natural boundary of Slocan Lake; thence northerly along said natural boundary of Slocan Lake to the southeast corner of Lot 7686; thence westerly, northerly and easterly along the southerly, westerly and northerly boundaries of said Lot 7686 to the northeast corner thereof, said corner being a point on the natural boundary of Slocan Lake; thence northerly along said natural boundary of Slocan Lake to the northeast corner of Lot 9300, said corner being the point of commencement.
