EXECUTIVE COUNCIL CHAMBERS, VICTORIA 25 SEP. 1975

Pursuant to the Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) no free miner shall stake or acquire a location on any of the lands within the following described area in the Victoria Mining Division, Sahtlam, Helmcken, Malahat and Cowichan Land Districts:

An area one mile wide being one-half mile on each side of the center line of the right-of-way of the proposed British Columbia Hydro and Power Authority Sahtlam-
~~Dunsmuir~~ 500 K.V. transmission line as shown on maps 1 to A5, Volume 377, File 113, in the office of the Chief Gold Commissioner, Department of Mines and Petroleum Resources, Victoria, British Columbia,

- (2) upon the expiry of the term or cancellation of any placer claim or lease the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no free miner shall stake on such lands.

- (3) the lands described above are hereby designated as placer reserves.

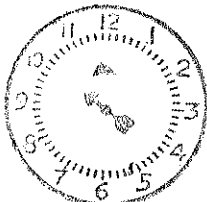
