EXECUTIVE COUNCIL CHAMBERS, VICTORIA 12. JAN. 1976

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Administrator, by and with the advice and consent of the Executive Council, orders that

*[Signature]*

(1) no person shall locate upon and no Free Miner shall stake on any of the lands within the following described area in the Vancouver Mining Division, Range 1, Coast Land District:

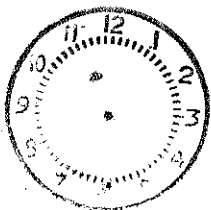
commencing at a point on the southerly boundary of Lot 833, (T.L. 7852), said point being 15 chains east of the most southerly southwest corner of said Lot 833; thence due north 20 chains; thence due east 45 chains; thence due south 30 chains; thence due west 45 chains more or less to a point due south of the aforesaid point of commencement; thence north 10 chains more or less to said point of commencement;

(2) upon the expiry of the term or cancellation of any existing mineral claim, placer claim or lease, or lease issued under the Mineral Act or upon the reversion to the Crown in the right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no person shall locate upon and no free miner shall stake on such lands;

and

(3) with respect to the Placer Mining Act the lands described above are hereby designated as placer reserves.
