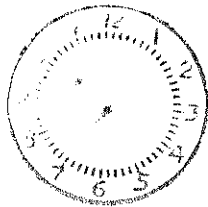

EXECUTIVE COUNCIL CHAMBERS, VICTORIA 21. JUL 1977

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

(1) no person shall record or locate upon and no free miner shall stake on any of the lands within the following described areas in the Vancouver Mining Division, Range 1, Coast Land District, in the period commencing on the date of approval of this Order and terminating July 31, 1992.

(a) Commencing at a point 12 chains due south and 8 chains due west of the northwest corner of Lot 204, Range 1, Coast Land District, thence due west 25 chains; thence due south 15 chains; thence due east 25 chains; thence north 15 chains more or less to the aforesaid point of commencement.

(b) Commencing at a point 12 chains south of the northwesterly corner of Lot 213 Range 1 Coast Land District more or less; thence due east 32 chains; thence due south 30 chains; thence due west 55 chains; thence due north 30 chains; thence due east 23 chains more or less to aforesaid point of commencement.

(2) upon the expiry of the term or cancellation of any existing mineral claim, placer claim or lease, or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no person shall record or locate upon and no free miner shall stake on such lands;

and
(3) with respect to the Placer Mining Act the lands described above are hereby designated as placer reserves.
