*[Signature]* EXECUTIVE COUNCIL CHAMBERS, VICTORIA 20. OCT. 1977

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the ~~Lieutenant-Governor~~ Administrator, by and with the advice and consent of the Executive Council, orders that no person shall locate upon and no free miner shall stake on or acquire a location in or upon any of the lands within the areas described in Schedule "A" attached hereto and made a part hereof, which lands are situated in the Fort Steele Mining Division, Kootenay Land District; which lands are hereby designated as placer reserves under the Placer Mining Act,

except in accordance with and subject to the following terms and conditions:

1. No holder of a mineral claim or lease issued under the Mineral or Placer Mining Acts, that may hereafter be located within the area outlined above, shall be entitled to any surface rights in that area used by Elco Mining Limited, its successors and assigns, for the construction of roads, powerlines, townsites or structures of any kind whatsoever, which may come into existence on the said mineral claim or lease as a result of such construction.
2. No holder of a mineral claim or lease issued under the Mineral or Placer Mining Acts, that may hereafter be located within the area outlined above, or any person exploring, developing, mining or working in any way the said mineral claim or lease, shall be entitled to any claim for damage which may be caused by the aforesaid construction of roads, powerlines, townsite or structures of any kind whatsoever which may come into existence on the said mineral claim or lease as a result of such construction.

AND FURTHER ORDERS THAT upon the expiry of any mineral claim or lease issued under the Mineral or Placer Mining Acts which lies within the area outlined above, the lands covered by any such mineral claim or lease shall become and are hereby constituted a reservation under the terms of this Order.

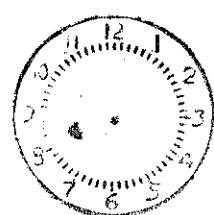

Schedule "A"

Which forms part of Order in Council No. 3207

- (a) Commencing at the southwest corner of Lot 8965; thence West 2 000 m; thence North 9 500 m; thence East 1 500 m more or less to the natural boundary of the right bank of the Elk River; thence southerly along said natural boundary to a point due East of the southwest corner of Lot 8965; thence due West 700 m more or less to the southwest corner of Lot 8965, being the point of commencement.
- (b) Commencing at the southwest corner of Lot 6837; thence West 800 m more or less to the westerly boundary of Lot 9480; thence northerly along the westerly boundaries of Lots 9480, 9482 and 9483 to the northwest corner of Lot 9483; thence North 3 000 m more or less; thence due East 2 000 m more or less to the northwest corner of Lot 9485; thence easterly and southerly along the northerly and easterly boundaries of said Lot 9485 to the southeast corner thereof; thence due south to the natural boundary of the right bank of the Elk River; thence southerly along the said natural boundary to a point due East of the southwest corner of Lot 6837; thence due West 700 m more or less to the southwest corner of Lot 6837, being the point of commencement.
