EXECUTIVE COUNCIL CHAMBERS, VICTORIA 17. NOV. 1977

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the ~~Lieutenant-Governor~~ *Administrator*, by and with the advice and consent of the Executive Council, orders that

(1) no person shall record or locate upon and no free miner shall stake on any of the lands within the area described in Schedule "A" attached hereto and made a part hereof which lands are situated in the Golden, Fort Steele and Slocan Mining Divisions, Kootenay Land District, in the period commencing on the date of approval of this order and terminating December 31, 1978;

Noted

(2) upon the expiry of the term or cancellation of any existing mineral claim, placer claim or lease, or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no person shall record or locate upon and no free miner shall stake on such lands;

and

(3) with respect to the Placer Mining Act the lands described in Schedule "A" are hereby designated as placer reserves.

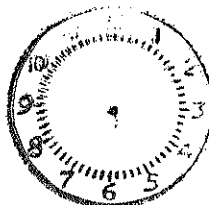

Schedule "A"

Forms part of Order in Council No.

Commencing at the most easterly point on the boundary of St. Mary's Alpine Park; being a point on the southerly boundary of the watershed of Skookumchuck Creek; thence in a general easterly and southeasterly direction along the said boundary to the summit of Sawtooth Park; ^{PEAK} thence due east to the 6400 foot contour line; thence easterly, northeasterly and westerly along the said 6400 foot contour line which runs westerly of Buhl Creek and southerly of Skookumchuck Creek to the northerly boundary of Lot 4592; thence westerly along the said northerly boundary of Lot 4592 to the easterly boundary thereof; thence northerly along the said easterly boundary of Lot 4592, a distance of 805 m more or less to the southerly boundary of the watershed of an unnamed creek which flows easterly into Skookumchuck Creek; thence westerly along the said boundary to the easterly boundary of the watershed of Alton Creek; thence northerly along the said easterly boundary of the watershed of Alton Creek and continuing northerly along the easterly boundaries of the watersheds of those unnamed creeks flowing westerly into Findlay Creek to a point lying 13 680 m South 15° 30' West of the summit of Barn Mountain; thence northeasterly in a straight line to the said summit of Barn Mountain; thence northwesterly in a straight line to the summit of Mount Earl Grey; thence southwesterly in a straight line to the summit of Red Top Mountain; thence southwesterly in a straight line to the summit of Blockhead Mountain, being a point on the northerly boundary of the watershed of Hamill Creek; thence westerly along the said northerly boundary of the watershed of Hamill Creek to a point due east of the most easterly southeast corner of Lot 825; thence southeasterly in a straight line to the summit of Comb Mountain being a point on the northerly boundary of the watershed of Clint Creek; thence easterly along the northerly boundary of the watershed of Clint Creek and the southerly boundary of the watershed of Hamill Creek to the summit of Mount Hamill; thence southeasterly in a straight line to the summit of Mount Pambrun, being a point on the westerly boundary of the watershed of Pork Creek; thence southerly along the said westerly boundary of the watershed of Pork Creek to the northerly boundary of the watershed of Fry Creek; thence westerly along the said northerly boundary of the watershed of Fry Creek to the confluence of Fry Creek and Carney Creek; thence southeasterly in a straight line to the summit of Mount Tyrell, being a point on the northeasterly boundary of the watershed of Clute Creek; thence southeasterly along the northeasterly boundaries of the watersheds of Clute Creek and Campbell Creek to the westerly boundary of the watershed of St. Mary River; thence southerly along the westerly boundary of the watershed of the main stream of St. Mary River to a point lying North 74° East of the summit of Mount Loki; thence northeasterly in a straight line to the intersection of the middle-line of Dewar Creek with the westerly boundary of Lot 4592; thence due east in a straight line to the westerly boundary of St. Mary's Alpine Park; thence northerly, easterly and southerly along the westerly, northerly and easterly boundaries of St. Mary's Alpine Park to the aforesaid most easterly point thereon, being the point of commencement.
