Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenami-Governor, by and with the advice and consent of the Executive Council, orders that

(1) no free miner shall record or locate upon and no free miner shall stake or acquire a location in or on any of the lands within the following described area in the Revelstoke Mining Division, Kootenay Land District:

Commencing at the southeast corner of Lot 2110; thence north to the northerly boundary of Lot 8683; thence east 2 900 m; thence south 3 400 m; thence westerly 2 900 m, more or less, to the southeast corner of Lot 2110, being the point of commencement.

(2) upon the expiry of the term or cancellation of any existing mineral claim, 2 post claim, mining lease, certified mining lease, placer lease or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no free miner shall record or locate upon and no free miner shall stake on such lands;

and

(3) with respect to the Placer Mining Act the lands described above are hereby designated as placer reserves.
