EXECUTIVE COUNCIL CHAMBERS, VICTORIA JUN. -7, 1979

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) no free miner shall record or locate upon and no free miner shall stake on any of the lands within the following described area in the Liard Mining Division, Peace River Land District, all lying within Township 83 Range 19 W6M:

Commencing at the southwest corner of section 27; thence northerly on the west boundary of the said section 27 to the north boundary of the south half of said section 27, thence easterly on the said north boundary of the south half of section 27 and the north boundary of the southwest quarter of section 26 to the east boundary of the said southwest quarter of section 26; thence southerly on the said east boundary of the southwest quarter of section 26 and the east boundary of the northwest quarter of section 23 to the north boundary of the south half of said section 23; thence easterly 500 m on the north boundary of the said south half of section 23; thence due south to the south boundary of section 11; thence westerly on the said south boundary of section 11 and the south boundaries of sections 10, 9 and 8 to the east boundary of Lot 2222; thence northerly on the said east boundary of Lot 2222 to the natural boundary of the right bank of the Moberly River; thence generally northeasterly on said natural boundary of the right bank of the Moberly River to the natural boundary of the right bank of the Peace River; thence due north to the natural boundary of the left bank of the Peace River; thence generally northwesterly on the said natural boundary of the left bank of the Peace River to the west boundary of the northeast quarter of section 21; thence northerly on the said west boundary of the northeast quarter of section 21 to the north boundary of the said northeast quarter of section 21; thence easterly on the said north boundary of the northeast quarter of section 21 to the southwest corner of section 27, being the point of commencement.

- (2) upon the expiry of the term or cancellation of any existing mineral claim, 2 post claim, mining lease, certified mining lease, placer lease or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted 2 post claim the lands formerly


