On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (a) Order in Council 641/71 be repealed, and
- (b) the following regulation be made:

1. No free miner shall
  - (a) record or locate a mineral claim, or
  - (b) stake or acquire a location
 on the following areas in the Victoria Mining Division:
  - (i) Lots 1 and 2 of Section 1, Range 2, West, North Saanich Land District, Plan 10164, except the most easterly 10 chains of Lot 2;
  - (ii) Lots 45 and 67, Highland Land District;
  - (iii) All those parts of Lots 48, 49, 44 and 45A, Highland Land District, consisting of a strip of land 1 chain in width measured inland from the high water mark;
  - (iv) Lots 158, 174, 175, 176, 177, 178 179 and 180, Sooke Land District;
  - (v) The most westerly 20 chains of Lots 29 and 37, Goldstream Land District, and all that portion of Lot 102, Metchosin Land District, east of the pipeline right of way, Plan 362;
  - (vi) Unsurveyed islands, known as Haystack Islets in Parry Bay, Esquimalt Land District.

2. In respect to the Placer Mining Act, the lands referred to in section 1 are placer reserves.
