EXECUTIVE COUNCIL CHAMBERS, VICTORIA MAR -1. 1979

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that the following described area in the Victoria Mining Division, Esquimalt Land District, be and is hereby designated as designated placer land.

Commencing at the Northeast corner of Section 55; thence Westerly along the North boundary of the said Section 55 and Section 38 to the Northwest corner of the said Section 38; thence Southerly along the West boundary of the said Section 38 to Southwest corner thereof; thence Easterly to a point on the South boundary of the said Section 38 lying concurrent with the North projection of the East boundary of Lot 1, Plan 6906, on file in the Land Registry Office, Victoria; thence Southerly to the Southeast corner of the said Lot 1; thence westerly to the Southwest corner of the said Lot 1; thence Southerly along the West boundaries of Sections 39, 40 and 41 to the Southwest corner of the said Section 41; thence Easterly along the South boundaries of the said Section 41 and Section 53 to West boundary of Farhill Road right-of-way; thence Northeasterly along the said West boundary of Farhill Road right-of-way to a point lying concurrent with a West projection of the North boundary of Lot 10, Plan 1496, on file in the Land Registry Office, Victoria, B.C.; thence Easterly to the Northeast corner of the said Lot 10; thence Northerly on the East boundaries of Sections 53, 54, 16, and 55 to the Northeast corner of the said Section 55, being the point of commencement.
