EXECUTIVE COUNCIL CHAMBERS, VICTORIA MAR. 15 1979

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) no free miner shall record or locate upon and no free miner shall stake or acquire a location in or on any of the lands within the following described area in the New Westminster and Nicola Mining Divisions, Yale Division of Yale Land District, in the period commencing on the date of approval of this Order and terminating November 30, 1981:

Commencing at the summit of Zupjok Peak; thence south 10° east 5 550 m more or less to the southeast boundary of the watershed of Boston Bar Creek; thence easterly on the said southeast boundary of the watershed of Boston Bar Creek to the summit of Needle Peak; thence north 67° east 9 750 m more or less to the 121° Meridian of West Longitude; thence due north 6 400 m; thence due west 4 100 m more or less to the south boundary of the watershed of an unnamed creek flowing easterly into the Coldwater River within Section 26 Township 8 Range 23 W 6 M; thence westerly on the said south boundary of the unnamed creek to the south boundary of the watershed of Juliet Creek; thence westerly on the said south boundary of the watershed of Juliet Creek to the west boundary of the watershed of the Coldwater River; thence southerly on the said west boundary of the watershed of the Coldwater River to Zupjok Peak, being the point of commencement.

- (2) upon the expiry of the term or cancellation of any existing mineral claim, 2 post claim, mining lease, certified mining lease, placer lease or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted 2 post claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no free miner shall record or locate upon and no free miner shall stake on such lands;

and

- (3) with respect to the Placer Mining Act the lands described above are hereby designated as placer reserves.
