EXECUTIVE COUNCIL CHAMBERS, VICTORIA MAY 14.1980

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- 1. No free miner shall
 - (a) record or locate a mineral claim, or
 - (b) stake or acquire a location on the following areas

i. in the Cariboo Mining Division, Cariboo Land District:

Commencing at a point 300 m westerly of the northeast corner of lot 6640, said point being on the north boundary of said lot 6640; thence N 25° W 2 100 m, more or less, to the natural boundary of the Bowron River, on the left bank thereof; thence generally southerly along the said natural boundary of the Bowron River, on the left bank thereof, to the point of intersection with the east boundary of lot 6640; thence northerly 150 m along the said east boundary of lot 6640; thence due west 400 m; thence S 27° W 1 200 m; thence N 63° W 250 m; thence N 27° E 1 100 m; thence due west 400 m; thence due north 350 m; thence northeasterly 900 m, more or less, to a point 300 m due west and 150 m due south of the northeast corner of lot 6640; thence northerly 150 m, more or less, to a point 300 m westerly of the northeast corner of lot 6640, said point being on the north boundary of said lot 6640, being the point of commencement.

ii. in the Omineca Mining Division, Range 4, Coast Land District:

Commencing at the northwest corner of lot 3064; thence easterly along the north boundary of said lot 3064 to the west boundary of lot 3065; thence northerly along the said west boundary of lot 3065 to the northwest corner thereof; thence easterly along the north boundary of said lot 3065 to the point of intersection with the natural boundary of the Nechako River on the left bank thereof; thence due south in a straight line to a point on the natural boundary of the Nechako River on the right bank thereof; thence generally northeasterly along the said natural boundary of the Nechako River on the right bank thereof to the point of intersection with the east boundary of lot 3088; thence southerly along the said east boundary of lot 3088 to the southeast corner thereof; thence westerly along the south boundary of said lot 3088




