EXECUTIVE COUNCIL CHAMBERS, VICTORIA OCT. 29. 1980

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that B.C. Regs. 116/77 and 535/77 be repealed and the following described area in the Cariboo Mining Division, Cariboo Land District, be and is hereby designated as designated placer land.

Commencing at the point of intersection of the natural boundary of Whittier Creek on the right bank thereof with the natural boundary of the Fraser River on the right bank thereof; thence due north to the natural boundary of the Fraser River on the left bank thereof; thence in a general southerly direction along the natural boundary of the Fraser River on the left bank thereof to the north boundary of lot 7266; thence due west 2 500 m; thence in a general northerly direction parallel to and perpendicularly distant 1 500 m westerly from the natural boundary of the Fraser River on the left bank thereof to a point due south of the point of intersection of the natural boundary of Whittier Creek on the right bank thereof with the natural boundary of the Fraser River on the right bank thereof; thence due north to the said point of intersection of the natural boundary of Whittier Creek on the right bank thereof with the natural boundary of the Fraser River on the right bank thereof being the point of commencement.
