EXECUTIVE COUNCIL CHAMBERS, VICTORIA DEC. 12.1980

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that the following described areas be and are hereby designated as designated placer land.

An area in the Omineca Mining Division, Cassiar Land District, being 1 000 m either side of the center line of the Osilinka River from the point of intersection of the natural boundary of Omineca River on the right bank thereof with the natural boundary of Osilinka River on the left bank thereof to a point 20 km upstream of the said point of intersection of Osilinka River and Omineca River.

An area in the Cariboo Mining Division, Cariboo Land District, being 1 000 m either side of the center line of Muskeg River from a point 2 000 m upstream of the point of intersection of the natural boundary of Kaminski Creek on the left bank thereof with the natural boundary of Muskeg River on the right bank thereof to a point 8 000 m downstream from said point of intersection of Muskeg River and Kaminski Creek.
