EXECUTIVE COUNCIL CHAMBERS, VICTORIA JUN.-4.1981

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that the following described areas be and are hereby designated as designated placer land.

- (1) In the Clinton Mining Division, Lillooet Land District, an area 4 000 m wide, being 2 000 m on each side of the centre line of the Fraser River from the point of intersection of the natural boundary of the Fraser River on the right bank thereof with the natural boundary of the Chilcotin River on the right bank thereof downstream to the point of intersection of the centre line of the Fraser River with the easterly prolongation of the centre line of Gaspard Creek.
- (2) In the Clinton and Cariboo Mining Divisions, Lillooet and Cariboo Land Districts, an area 4 000 m wide, being 2 000 m on each side of the centre line of the Fraser River from the point of intersection of the centre line of the Fraser River with the easterly prolongation of the south boundary of Section 23, Township 48, Lillooet Land District, upstream to the point of intersection of the centre line of the Fraser River with the westerly prolongation of the south boundary of lot 5090, Cariboo Land District.
