EXECUTIVE COUNCIL CHAMBERS, VICTORIA JUN. -4.1981

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that the following described area in the Cariboo Mining Division, Cariboo Land District, be and is hereby designated as designated placer land.

Commencing at the point of intersection of the mean high water mark of the Fraser River on the right bank thereof with the easterly prolongation of the north boundary of lot 873; thence easterly along the said easterly prolongation of the north boundary of lot 873 to the mean high water mark of the Fraser River on the left bank thereof; thence generally southeasterly, southwesterly and northwesterly along the said mean high water mark of the Fraser River to the point of intersection with southerly prolongation of the west boundary of lot 875; thence northerly along the said southerly prolongation of the west boundary of lot 875 to the mean high water mark of the Fraser River on the right bank thereof; thence generally southeasterly, northeasterly and northwesterly along the said mean high water mark of the Fraser River to the point of intersection with the easterly prolongation of the north boundary of lot 873, being the point of
