EXECUTIVE COUNCIL CHAMBERS, VICTORIA JUL 30.1981

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that the following described area in the Skeena Mining Division, Queen Charlotte Land District, be and is hereby designated as designated placer land.

Commencing at the northeast corner of lot 749; thence southerly along the east boundary of said lot 749 to the north boundary of lot 985; thence easterly and southerly along the north and east boundaries of said lot 985 to the north boundary of lot 807A; thence easterly along the said north boundary of lot 807A to the northeast corner thereof; thence southerly along the east boundaries of lots 807A and 984 to the northwest corner of lot 804; thence easterly 800 m along the said north boundary of lot 804; thence southerly to a point on the north boundary of lot 803, said point being 800 m from the southwest corner of lot 804; thence easterly along the north boundary of lot 803 to the northeast corner thereof; thence southerly along the east boundary of said lot 803 to the northwest corner of lot 799; thence easterly and southerly along the north and east boundaries of said lot 799 to the northeast corner of lot 792; thence southerly along the east boundaries of lots 792 and 781 to the north boundary of lot 225; thence westerly and southerly along the north and west boundaries of lot 225 to the south boundary of lot 781; thence westerly along the said south boundary of lot 781 and the westerly prolongation thereof to the mean high water mark of Masset Sound on the east shore thereof; thence generally northerly along the said mean high water mark of Masset Sound to the point of intersection with the westerly prolongation of the north boundary of lot 749; thence easterly along the said westerly prolongation and the north boundary of lot 749 to the northeast corner thereof, being the point of commencement.
