EXECUTIVE COUNCIL CHAMBERS, VICTORIA SEP. 16.1982

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- The following described land in the Cariboo Mining Division, Cariboo Land District is established as a mineral reserve and as a placer mining reserve.

Commencing at the southeast corner of Indian Reserve number 2, thence easterly along the easterly prolongation of the south boundary of Indian Reserve number 2 to the middle line of the Fraser River, thence generally southerly along the middle line of the Fraser River to the point of intersection with the easterly prolongation of the southerly boundary of Lot 1 of District Lot 15 Plan 9538, thence southwesterly along the easterly prolongation of the southerly boundary of Lot 1 of District Lot 15 Plan 9538 to the southeast corner of Lot 1 of District Lot 15 Plan 9538, thence on a bearing of S 70° 12' 20" W a distance of 103.5 m to the southwest corner of Lot 1 of District Lot 15 Plan 9538, thence on a bearing of N 38° 35' W a distance of 33.7 m to the southeast corner of Lot B of District Lot 15 Plan 19604, thence on a bearing of N 87° 14' W a distance of 546.1 m to the southwest corner of Lot A of District Lot 15 Plan 19604, thence on a bearing of N 2° 47' E a distance of 320.1 m to the south boundary of Indian Reserve number 2, thence easterly along the south boundary of Indian Reserve number 2 to the southeast corner of Indian Reserve number 2, said corner being the point of commencement.

- No free miner shall stake or acquire a location or record or locate mineral claim in the reserve created by Section 1.
