On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

1. The following lands are established as a mineral reserve and as a placer mining reserve until September 1, 1984:

1) All those lands within the Nelson Mining Division, Kootenay Land District more particularly described as:

Commencing at the northwest corner of lot 789; thence southerly along the westerly boundary of said lot 789 to the northeasterly corner of lot 255; thence westerly along the northerly boundaries of lots 255 and 791 to a point 175 m westerly of the northeast corner of said lot 791; thence due north 1 100 m; thence N 55° E 1 850 m; thence due south 1 700 m, more or less, to the northerly boundary of lot 789; thence westerly along the said northerly boundary of lot 789 to the northwest corner thereof, being the point of commencement.

2) All those lands within the Skeena Mining Division, Range 2 Coast Land District more particularly described as:

1) Commencing at the northwest corner of lot 885; thence easterly along the ~~northeast~~ <sup>northerly</sup> boundary of lot 885 to the northeast corner thereof; thence southerly along the easterly boundaries of lots 885, 884, 883, 882 and 901 to the point of intersection of the easterly boundary of lot 901 with the northerly boundary of lot 903; thence easterly along the said northerly boundary of lot 903 to the northeast corner thereof; thence southerly along the easterly boundaries of lots 903 and 904 to the southeast corner of said lot 904; thence westerly along the southerly and southeast corner of said lot 904; thence westerly along the southerly boundary of lot 904 and the westerly prolongation of the southerly boundary of lot 904 to the mean high water mark of the Queen Charlotte Sound; thence northerly along the said mean high water mark of the Queen Charlotte Sound to its point of intersection with the westerly prolongation of the northerly boundary of lot 889; thence easterly along the said westerly prolongation of the northerly boundary of lot 889 and the northerly boundary of lot 889 to the northwest corner of lot 885, being the point of commencement.

3) All those lands within the Skeena Mining Division, Range 5 Coast Land District more particularly described as:

Commencing at the northwest corner of lot 4941; thence easterly along the northerly boundary of said lot 4941 to the westerly boundary of lot 4940A; thence northerly and easterly along the westerly and northerly boundaries of said lot 4940A to the westerly boundary of lot 28; thence northerly and easterly along the westerly and northerly boundaries of said lot 28 to the southwest corner of lot 4417; thence northerly and easterly along the westerly and northerly boundaries of said lot 4417 to the westerly boundary of 4405; thence northerly 300 m along the said westerly boundary of lot 4405; thence due east 700 m, more or less, to the natural boundary of McNeil River on the right bank thereof; thence generally northerly, easterly and westerly along the said right bank of McNeil River to its point of intersection with the natural boundary of Gamble Creek on the right bank thereof; thence generally westerly along the said right bank of Gamble Creek to its point of intersection with the southerly boundary of lot 4418; thence westerly and northerly along the southerly and westerly boundaries of said lot 4418 to the southeast corner of lot 5459; thence westerly along the southerly boundary of lot 5459 and the westerly prolongation thereof to the point of intersection with the easterly boundary of the watershed of Rainbow Lake; thence generally southerly and westerly along the easterly and southerly boundaries of the watershed of Rainbow Lake to the point of intersection with the easterly boundary of lot 3079; thence southerly along the said easterly boundary of lot 3079 and the easterly boundary of lot 4011 to a point due west of the northwest corner of lot 4941; thence due east 1 450 m, more or less, to the said northwest corner of lot 4941, being the point of commencement.

4) All those lands within the Golden Mining Division, Kootenay Land District more particularly described as:


Commencing at the point of intersection of the natural boundary of Akunam Creek on the right bank thereof with the natural boundary of North Fork White River on the right bank thereof; thence southerly 1 500 m along the said natural boundary of North Fork White River; thence ~~S 700 W~~ <sup>WRONG</sup> 4 500 m; thence due north 2 500 m; thence N 60° E 3 350 m, more or less, to the natural boundary of Schofield Creek on the right bank thereof, thence southerly along the said natural boundary of Schofield Creek on the right bank thereof to its point of intersection with the natural boundary of North Fork White River on the right bank thereof; thence southerly along the said natural boundary of North Fork White River on the right bank thereof; thence southerly along the said natural boundary of North Fork White River on the right bank thereof to its point of intersection with the natural boundary of Akunam Creek on the right bank thereof, being the point of commencement.
