EXECUTIVE COUNCIL CHAMBERS, VICTORIA JUN. 19.1985

On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

1. B.C. Reg. 238/77 be repealed.
2. The following described land in the Atlin Mining Division, Cassiar Land District, is established as a mineral reserve and as a placer mining reserve:

Commencing at Survey Monument number 120, on the British Columbia - Alaska International boundary;

thence southeasterly along said boundary a distance of 1 000 m; thence in a general northeasterly direction along the southerly boundary of the watershed of Lindeman Lake to Survey Monument Fraser; thence northeasterly in a straight line to the point of intersection of the 59° 44' 50" parallel of north latitude with the 135° 00' meridian of west longitude; thence N 58° E in a straight line to the point of intersection with the 915 m contour of elevation; thence due east to the point of intersection with the westerly limit of the right-of-way of the White Pass and Yukon Railway; thence in a general westerly and northerly direction along the aforementioned right-of-way to a point due east of Survey Monument Bennett S. Base; thence due west to the natural boundary on the mean high water mark of Bennett Lake on the southerly shore thereof; thence in a general westerly and northerly direction along the said natural boundary of Bennett Lake to the point of intersection with the northerly boundary of District Lot 31; thence westerly along the said northerly boundary of Lot 31 to the northwest corner thereof; thence due west a distance of 2 000 m; thence S 35° 00' W a distance of 5 000 m, more or less, to the point of intersection with the northerly boundary of the watershed of Lindeman Lake; thence in a general westerly direction along the said northerly boundary to the point of intersection of the 59° 48' 40" parallel of north latitude with the 135° 08' 05" meridian of west longitude; thence southwesterly a distance of 550 m, more or less, to the point of intersection with the 1 585 m contour of elevation; thence in a general southwesterly direction a distance of 100 m, more or less, to the headwaters of an unnamed creek;

thence downstream along the middle line of said unnamed creek to the point of intersection of the southerly prolongation of the middle line of said creek with the natural boundary of Lindeman Creek on the left bank thereof; thence upstream along the said natural boundary of Lindeman Creek on the left bank thereof to its intersection with the natural boundary of Mountain Lake on the northwesterly shore thereof; thence southwesterly on the said natural boundary of Mountain Lake to a point due west of the point of intersection of the middle line of Lindeman Creek with the said natural boundary of Mountain Lake on the southerly shore thereof; thence due west to the point of intersection with the 762 m contour of elevation; thence in a general southwesterly direction along the said 762 m contour of elevation to its point of intersection with the natural boundary of Lindeman Creek on the right bank thereof; thence in a southwesterly direction upstream along the said right bank of Lindeman Creek to its headwaters; thence southwesterly in a straight line to the point of intersection with the British Columbia - Alaska International Boundary, said line being perpendicular to said boundary; thence generally southeasterly along the said boundary to Survey Monument number 120, being the point of commencement.

3. No free miner shall stake or acquire a location or record or locate a mineral claim in the reserve created by Section 2.
