EXECUTIVE COUNCIL CHAMBERS, VICTORIA FEB. 11. 1987

On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

- The following described lands in the Kamloops Mining Division, Kamloops Division of Yale Land District, are established as a mineral reserve and as a placer mining reserve:

Commencing at the Northwest corner of Legal Subdivision 8 of Section 27, Township 23, Range 13, West of the Sixth Meridian; thence Southerly along the Westerly boundary of Legal Subdivisions 8 and 1 to the point of intersection with the Northeasterly boundary of Adams Lake West Road; thence Southeasterly along the Northeasterly boundary of Adams Lake West Road to the point of intersection with a straight line bisecting the Westerly and Easterly boundaries of the North half of Legal Subdivision 12 of Section 23, Township 23, Range 13, West of the Sixth Meridian; thence easterly along the said line and its Easterly prolongation to a point 100.58 metres East of the Easterly boundary of the aforementioned Legal Subdivision 12; thence Northerly and parallel to the said Easterly boundary to the point of intersection with the natural boundary of Adams Lake on the Westerly shore thereof; thence generally Northerly along the said Westerly shore of Adams Lake to the point of intersection with the Northerly boundary of Legal Subdivision 8 of Section 27, Township 23, Range 13, West of the Sixth Meridian; thence Westerly along the said Northerly boundary to the Northwest corner of Legal Subdivision 8 of Section 27, Township 23, Range 13, West of the Sixth Meridian, being the point of commencement.
