**REGULATION OF THE CHIEF GOLD COMMISSIONER**


*Mineral Tenure Act and Coal Act*

I, Mark Messmer, Chief Gold Commissioner, Ministry of Energy, Mines and Low Carbon Innovation, order as follows:

- (a) the prohibition established by B.C. Reg. 91/60 is revoked, any mineral or placer reserve established by B.C. Reg. 91/60 is cancelled and B.C. Reg. 91/60 is repealed;
