Pursuant to Section 71 of the *Petroleum and Natural Gas Act* (the Act), sealed bids will be received up to **12:00 noon, Wednesday, September 10, 2014** for the privilege of obtaining petroleum and natural gas rights detailed in the parcel descriptions below.

Bids must be addressed to the Minister of Natural Gas Development, and submitted to the office of the Executive Director, Tenure and Geoscience Branch, Upstream Development Division, 6th floor, 1810 Blanshard Street, PO Box 9326, Stn Prov Govt, Victoria BC, V8W 9N3.

Bidding procedures and requirements are detailed in the Guide to Bidding and Dispositions of Crown Petroleum and Natural Gas Rights. In order to be considered, a bid must be prepared and submitted consistent with the requirements specified in the Guide to Bidding and Disposition of Crown Petroleum and Natural Gas Rights.

A bid is evaluated against other bids received for the parcel, the geological potential of the parcel, and historical and current bidding trends. Tenure is awarded based on this evaluation. The Minister reserves the right to reject any or all bids if it is determined that acceptance of the bid(s) would not be in the best interest of the Crown.

Tenure is issued in accordance with and conveys the rights described in the Act.

The Ministry considers referral comments received from provincial resource management agencies, regional districts, municipalities and First Nations and includes relevant information in the parcel descriptions. A tenure holder must apply to the Oil and Gas Commission for activity permits, which are issued in accordance with the *Oil and Gas Activities Act*. The issuance of tenure does not guarantee the issuance of a permit to conduct oil and gas activity. The Commission may impose conditions on activity permits.

Successful bidders should be aware that they will be required to abide by the various laws governing exploration and development whether or not specific terms are listed in this notice. Laws governing exploration and development may be amended from time to time.

Tenure Types and Rights Conferred:

Permits confer the exclusive right to apply under the Oil and Gas Activities Act to do exploratory drilling for petroleum, natural gas or both on land owned by the government and within the boundaries of the location of the permit. The issue or existence of a permit does not prohibit a person other than the holder of the permit from carrying out geological work or geo physical exploration in accordance with the Oil and Gas Activities Act. (PNG Act, s. 38(1) and (2))

Drilling licences confer the right to explore for petroleum and natural gas. (PNG Act: Drilling Licence Regulation, s.1)

Leases confer the exclusive right to produce, in accordance with the Petroleum and Natural Gas Act and the Oil and Gas Activities Act, both the petroleum and natural gas from the location of the lease. (PNG Act, s. 50)
