1. Data Limitations & Data Suppression

The data presented is collected in accordance with the <u>Federal Regulations for the</u> <u>Monitoring of Medical Assistance in Dying</u> (the Regulations) that came into force on November 1, 2018. In British Columbia, the Ministry of Health was designated as the recipient of all federally reportable information for the province. Medical practitioners and nurse practitioners are required to report on all written requests for MAiD, and pharmacists must report on the dispensation of drugs for the purposes of MAiD. Any MAiD Request signed prior to November 1, 2018, was not subject to the Regulations, and therefore the available data for MAiD provisions prior to that date is more limited.

To protect the personal health information and privacy of those who have requested or received MAiD, statistics involving small numbers (less than a dozen individuals) have been suppressed to remove the risk of potential identification of individuals through the combination of datasets.

Medical Condition Explanatory Note: The data in table 3.4 indicates the proportion of individuals each year who received MAiD who had each underlying illness, disease, or disability, as indicated on the Prescribing Practitioner's Assessment records during that period. As some individuals have multiple underlying medical conditions, the percentages for each year do not total to 100%. The occurrence of each condition may also be slightly higher than indicated due to medical conditions that have been reported only as part of the Multiple Co-Morbidities option and not as an individual condition.




4.2 Specialty of MAiD Prescribers in 2019


4.3 Specialty of MAiD Prescribers in 2020
