

BC PharmaCare Plagiocephaly Helmet Coverage

If your baby has been diagnosed with plagiocephaly, brachycephaly or craniosynostosis, PharmaCare may help pay for a helmet for them.

How to get help paying for your baby's helmet

- Make sure you have PharmaCare coverage before ordering the helmet. The helmet is covered under <u>Fair PharmaCare</u>, <u>Plan C (B.C. Income Assistance</u>) and <u>Plan F (Children in the At Home Program</u>). If you do not have Plan C or Plan F coverage, register for Fair PharmaCare at <u>gov.bc.ca/ahdc</u> or call 1-800-663-7100.
- 2. If your baby meets these requirements, the orthotist will have you sign <u>PharmaCare's Plagiocephaly</u> <u>Helmet form</u>.

	Age at start of helmet treatment	Qualifying requirements
Plagiocephaly	Between 5 months and 1 year	Cranial vault asymmetry index (CVAI) of 6.25% or more
Brachycephaly	Between 5 months and 1 year	Cranial vault asymmetry index (CVAI) of 95% or more
Craniosynostosis	Between 4 months and 1 year	 Has had surgery for the condition Written referral or prescription for a helmet from a pediatric neurosurgeon, and Has had a post-operative helmet cast or scan

If your baby **does not** meet the requirements above, you will need PharmaCare approval for coverage before you order the helmet. Your orthotist will have you sign the <u>PharmaCare Orthotic Benefits</u> — <u>Application for Financial Assistance form</u>.

- **3.** Order the helmet. Even if you have coverage, you may have to pay for the helmet and get reimbursed. Coverage under Fair PharmaCare depends on whether you have met your deductible or family maximum.
- 4. Submit the claim. In most cases, your orthotist will submit the claim for you. If you submit the claim, send it before March 31 of the year following the year you paid for the helmet. Mail the PharmaCare invoice and receipt and, if applicable, page 2 of the <u>PharmaCare Orthotic Benefits</u> <u>Application for Financial</u> <u>Assistance form</u>, showing PharmaCare's approval, to: PO Box 9655 Stn Prov Govt, Victoria BC V8W 9P2
