



6. Temporary or Student Registration	\$112.00
7. Reinstatement Fee (Full Classes)	\$161.00
8. Reinstatement Fee (Non-Practicing Class)	\$80.50
9. Examination	\$2500.00
10. Non-Sufficient Funds (NSF) Cheque Fee	\$25.00
11. Duplicate Receipts/Certificates	\$25.00
12. Duplicate Handbook (USB drive)	\$25.00
13. Health Profession Corporation Permit Fee	\$105.00
14. Health Profession Corporation Permit Renewal Fee	\$30.00
