





9. Examination\$2,500.00
10. Non-Sufficient Funds (NSF) Cheque Fee.....\$25.00
11. Duplicate Receipts/Certificates\$25.00
12. Duplicate Handbook (No binder - content only).....\$30.00
13. Health Profession Corporation Permit Fee.....\$105.00
