
ORDER OF THE MINISTER OF HEALTH





SCHEDULE

The bylaws made by the College of Dental Technicians of British Columbia under the authority of the *Health Professions Act* are amended as follows:

Section 35 (1), (2), and (3), are repealed and the following substituted:

(1) Applicants for registration must pay the College the following fees for consideration of their application:

(a)	Dental Technician	\$100.00
(b)	Non-practicing Dental Technician	100.00
(c)	Assistant	50.00
(d)	Student	0.00
(e)	Application for Prior Learning Assessment	250.00
(f)	Transfer Fee	200.00
	(from Dental Technician to Assistant and vice versa)	

(2) Applicants for registration must pay the College the following registration fees:

(a)	Dental Technician	\$725.00
(b)	Non-practicing Dental Technician	360.00
(c)	Assistant	300.00
(d)	Student	0.00

(3) Applicants for renewal of registration must pay the College the following registration renewal fees:

(a)	Dental Technician	\$650.00
(b)	Non-practicing Dental Technician	360.00
(c)	Assistant	325.00
(d)	Student	0.00
