**Consent of the Attorney General**

Cross-references:

Crown Counsel exercise the prosecution function as the Attorney General’s lawful agents. This agency relationship can be constrained by legislation, caselaw, and policy.

Various provisions of the *Criminal Code* and the *Youth Criminal Justice Act* require the consent or other action of the Attorney General. This authority of the Attorney General may be delegated, depending on the statutory language.

All consents should be confirmed in writing.

Crown Counsel can provide consent for all procedural provisions of the *Youth Criminal Justice Act*. Crown Counsel must obtain or may provide consent for *Criminal Code* provisions as follows:
