Charges Approved for Alleged Animal Cruelty at Chilliwack Dairy

Victoria - The Criminal Justice Branch (CJB), Ministry of Justice, announced today that charges have been approved under the British Columbia *Prevention of Cruelty to Animals Act* (PCAA) and the *Wildlife Act* (WA), following an investigation into allegations of animal cruelty at a dairy operation owned by Chilliwack Cattle Sales Ltd.

The events giving rise to these charges are said to have occurred in May 2014. A Report to Crown Counsel recommending charges was first received by the CJB in June 2014. The charge assessment process has been lengthy due to a variety of factors, including the nature of the initial investigation, the number of potential accused, complexity in assessing the evidence available against each potential accused, completion of further investigation by the enforcement agency, and delay in CJB's completion of the charge assessment.

Charges have now been approved against several employees for allegedly permitting animals to be, or to continue to be, in distress, in violation of section 9.1(2) of the PCAA, and for failing to protect animals from circumstances that were likely to cause the animals to be in distress, in violation of section 9.1(1) of the PCAA. Four of the employees also face a charge for allegedly molesting a pigeon, in violation of section 34(a) of the WA.

Charges under sections 9.1(1) and 9.1(2) of the PCAA have also been approved against Chilliwack Cattle Sales Ltd. as a corporate entity, and against corporate directors based on their legal responsibility for the proper operation of the facility.

The charges have been sworn in British Columbia Provincial Court in Chilliwack under court file 63894-1. First appearance in the matter has been scheduled for April 12, 2016. A copy of the sworn Information is attached to this Media Statement.
