Objective #2 – Conclude prosecutions in a timely manner

Actions

- 1.2.1. The BC Prosecution Service will endeavour to minimize delay in conducting prosecutions.
- 1.2.2. The BC Prosecution Service will pursue early resolution of prosecutions in a principled manner.

Objective #3 – Continue our reconciliation efforts with Indigenous Peoples

Action

- 1.3.1. The BC Prosecution Service will follow the path set out in the BCPS Indigenous Justice Framework.



Goal Two

The BC Prosecution Service has the tools, training, and resources to fulfill our responsibilities.

Objective #1 – Recruitment and Retention

Actions

- 2.1.1. The BC Prosecution Service will fill vacant positions through fair and transparent hiring competitions.
- 2.1.2. The BC Prosecution Service will strive for a workforce that is reflective of the people we serve.
- 2.1.3. The BC Prosecution Service will prioritize recruitment and retention to best serve remote communities.
- 2.1.4. The BC Prosecution Service will enhance the recognition, growth, and advancement of professional staff creating clear career pathways and opportunities for skill development.

Objective #2– Training and Development

Actions

- 2.2.1. The BC Prosecution Service will provide education, training, and information-sharing opportunities for our employees to support their work.
- 2.2.2. The BC Prosecution Service will support career development and succession planning.



Objective #3 – Technology

Actions

- 2.3.1. The BC Prosecution Service will dedicate technical and training resources to support our employees in the implementation and use of technology.
- 2.3.2. The BC Prosecution Service will expand the use of innovative technological tools to support prosecutions.
- 2.3.3. The BC Prosecution Service will provide data security education and training to safeguard sensitive information and ensure continued compliance with security standards.
