REFERRALS TO SEXUAL ASSAULT SERVICES AND SEXUAL ASSAULT CENTRES
July 21, 2025

PURPOSE

Note about language: A number of terms may be used to describe people who have experienced sexual assault, including victim, survivor, and client. In this document, the term survivor is used.

This information bulletin provides guidance and direction to Ministry of Public Safety and Solicitor General (MPSSG) funded and supported victim service and counselling programs working with people who have experienced sexual assault.¹ Collaboration across sectors and between organizations is essential for survivors to get the help that they need in a timely way and in a location that is accessible to and appropriate for them.

This information bulletin supplements the January 2007 **Referral Policy for Victims of Power-based Crimes** in order to update MPSSG's direction regarding referrals for survivors of sexual assault. New programs have been established in some communities to enhance services and options available to survivors. **MPSSG recognizes the many contributions and ongoing commitment of both police-based and community-based victim services to support sexual assault survivors. In communities where Sexual Assault Services (SAS) do not exist, these programs continue to be the primary service provider for sexual assault survivors, particularly where police-based are the sole victim service provider.**

CONTEXT

In July 2023, MPSSG awarded new contracts for sexual assault programs following an open procurement process led by the Community Safety and Victim Services Branch of MPSSG. The contracts provide new, specialized services for sexual assault survivors and increase community capacity and expertise to support survivors of sexual assault. In addition, Child and Youth Advocacy Centres (CYAC) have been introduced in some communities since the implementation of the 2007 Referral Protocol. The **Victim Services and Violence Against Women Service Directory** provides more detailed service descriptions for each community in the province. The services focused on sexual assault are:

- Sexual Assault Services (SAS) - provide a range of supports for survivors and coordination with justice, health and social services. Some programs are Indigenous focused.
- Sexual Assault Centres (SAC) - located in Prince George, Kamloops, Vancouver, Surrey, and Victoria. The SACs are intended to provide space for health care supports, Sexual Assault Forensic Examination, and police and other interviews in a trauma informed environment, and both coordination and counselling services. Victoria is long-established and operational while other Centres are in various stages of development.

In addition to these sexual assault services for survivors, supports are guided by ***policing standards*** for sexual assault investigations² and policy for the provision of Sexual Assault Forensic Examinations in hospital emergency departments which recognizes services may also be provided in community sites outside of hospitals.

REFERRAL DIRECTION

The ***Referral Policy for Victims of Power-based Crimes*** (2007)³ identifies two types of services: Police-based Victim Service Programs (PBVS) and Community-based Victim Service Programs (CBVS). With these additional and specialized services to support survivors of sexual assault, **Sexual Assault Services and Sexual Assault Centres are now included in this list of programs and considered the primary service providers for people who have experienced sexual assault in communities where they are available.**

Survivors of sexual assault should be referred to Sexual Assault Services and Sexual Assault Centres where available in a community.

The following are updates to the section “Referral Directive” included in the 2007 Referral Policy:

SERVICE EXPECTATIONS

All programs funded by the Community Safety and Victim Services branch of the MPSSG are intended to be survivor-centred, coordinated, culturally safe, and trauma-informed. Survivor service delivery should be guided by the survivor's needs and wishes. Survivors should be made aware of their options for support in their community.

Coordination - As stated in the ***Referral Policy for Victims of Power-based Crimes***, "a coordinated, multi-sectorial (i.e., involving a number of organizations) response empowers survivors of sexual assault and gender-based violence and is most effective in keeping them safe" and supporting healing. **All service providers must familiarize themselves with the various sexual assault programs in their area** to enable coordination and referrals to Sexual Assault Services and Sexual Assault Centres. This could include developing working agreements between organizations to clarify roles and expectations, often called Memorandums of Understanding (MOUs).

Service providers will make every effort to ensure **referrals are seamless and timely**. This will include establishing local relationships and agreements so that options for survivors are clear and the people helping them communicate as effectively as possible to enable referrals. This will include establishing agreements for information sharing.

The Community Safety and Victim Services Branch of the MPSSG will support and monitor coordination and is available to consult about particular issues in communities.

Age of survivor - People of any age can experience sexualized violence. There should be coordination regarding how best to support survivors under 19 years of age.⁹ Considerations include the age and maturity of the child or youth and resources in the community. **Sexual Assault Services and Sexual Assault Centres should develop protocols for coordination and referrals with local Child and Youth Advocacy Centres**. If the survivor is a child or youth under 19 years of age and needs protection, there is a legal Duty to Report.¹⁰ Provincial Centralized Screening can be contacted at 1-800-663-9122 any time of the day or night.

Health care - **The survivor should be offered medical examination and treatment and assured that these services are available regardless of whether they report their assault to police.**¹¹ The survivor should be connected with this care as soon as possible to treat injuries and manage exposure to sexually transmitted infections and risk of pregnancy. A survivor may choose to have their injuries documented and samples stored in the event they choose later to engage the police. Survivors can access medical care and forensic examination through:

- Sexual Assault Centres, which are the preferred option; and
- Emergency Departments within publicly funded hospitals.

People who have experienced sexual assault may continue to have health and psycho-social needs as a result of their assault. Organizations should work with the survivor to determine how to best address their needs and make appropriate referrals.
