Background

Under section 23(1) of the <u>Fire Safety Act</u>, a local authority (municipal council, regional district board or any authority prescribed by regulation) must designate fire investigators for the purpose of conducting fire investigations. Under section 23(2) of the Act, an individual who is designated as fire investigator must meet the training standard established by the fire commissioner.

The training standard established in this document is based on some of the applicable job performance requirements in the National Fire Protection Association (NFPA) 1033 (2022) Standard on Professional Qualifications for Fire Investigator and NFPA 1021 (2020) Standard for Fire Officer Professional Qualifications. The job performance requirements have been modified to establish an appropriate minimum standard for a designated local authority fire investigator.

Purpose

The Office of the Fire Commissioner (OFC) developed this document, the Fire Safety Act Fire Investigator Training Standard, as required by the Fire Safety Act section 4(1)(d)(ii) to establish the minimum standard for a fire investigator designated by a local authority under section 23(1) of the Fire Safety Act.

The fire investigator training standard

A fire investigator designated under the Fire Safety Act must, at a minimum, have the knowledge, skills and abilities to meet the job performance requirements described in Table 1, below.

When a job performance requirement has been adopted and modified from NFPA 1033 (2022) or NFPA 1021 (2020), the chapter and paragraph number is noted in

brackets after the skill requirement is described; for example, "[modified from NFPA 1021 (2020) - 4.5.3]".

Note: the requirements in the general knowledge category are not taken from NFPA standards. Therefore, no citation is provided.

Applying the standard

The OFC's Fire Safety Act fire investigator training standard is intended to be the minimum standard that must be met by any person who is designated as a fire investigator under the Fire Safety Act. A local authority may establish its own standard for the fire investigators that it designates, provided that its standard meets or exceeds the Fire Safety Act fire investigator training standard, as established by the fire commissioner.

Training for fire investigators to meet the standard

The OFC will provide fire investigator training and evaluation to the established standard in the OFC Basic Fire Investigator Fundamentals online course (to be released in late 2024). A designated fire investigator who has obtained the required competencies and meets the standard through other training and experience is not required to complete this training.

While the OFC Basic Fire Investigator Fundamentals online course is being developed, a local authority may wish to determine the required or acceptable training for its designated fire investigators against this published standard. The local authority can do this via the online Prior Learning Assessment and Recognition (PLAR) form to ensure the designated investigator meets the fire investigator training standard. It is the responsibility of the local authority to ensure the PLAR application form is accurate, signed off, and is retained in the personnel file of the designated fire investigator.

The fire investigator training standard PLAR form is available online here.

Local authority responsibilities

The Fire Safety Act requires local authorities (municipalities and regional districts) to designate local fire inspector(s) and fire investigator(s).

As in the Fire Services Act, the Fire Safety Act continues the requirement for all fires to be investigated and reported to the fire commissioner. Locally designated fire investigators may fulfil this requirement.

Regional districts

For regional districts under the Fire Safety Act.

- It is a requirement for regional districts to designate a local fire investigator.
- The Fire Safety Act places the requirement for all fires to be investigated and reported to the fire commissioner on the local authority (regional district).
- The regional district has the discretion to use their own designated fire investigator(s), or to request the OFC to conduct the fire investigation.
