<p>Protection of recreation and range resources on Crown land</p>	<p>58</p>	<p>(1) If the minister determines that it is necessary to protect a recreation or range resource or to manage public recreation use on Crown land, he or she by order may restrict or prohibit</p> <p>(a) a non-recreational use of</p> <p>(i) any of the following established under the <i>Forest Practices Code of British Columbia Act</i> for recreation:</p> <p>(A) a resource management zone;</p> <p>(B) a landscape unit;</p> <p>(C) a sensitive area, or</p> <p>(ii) any of the following that is on Crown land:</p> <p>(A) an interpretive forest site;</p> <p>(B) a recreation site or recreation trail,</p> <p>except any non-recreational use permitted under the <i>Coal Act</i>, the <i>Mineral Tenure Act</i>, the <i>Petroleum and Natural Gas Act</i> or the <i>Pipeline Act</i>, or</p> <p>(b) a recreational use anywhere on Crown land, except a use that is specifically permitted by or under another enactment.</p> <p>(2) The minister may make different orders under subsection (1) for different uses and locations.</p> <p>(3) The minister must post a notice of an order under subsection (1) in the area to which the order applies.</p> <p>(4) Without lawful authority, a person must not remove, alter, destroy or deface a notice posted under subsection (3)</p>	<p>Dir and RM</p>
