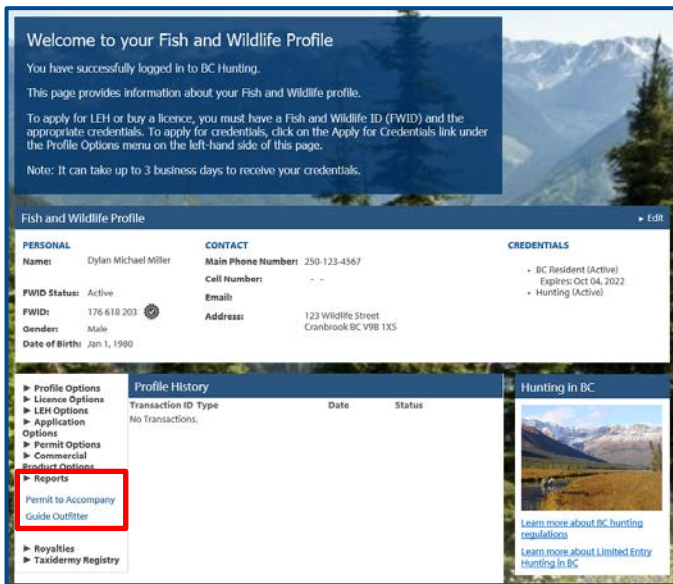


Permit to Accompany Report

Required when:	The report is required when the Hunt End Date on a Permit to Accompany has passed. The report must be submitted no more than 10 days after the Hunt End Date.
Who is eligible to submit?	The holder of a Permit to Accompany.
Royalties (these will make up the report fee)	<ul style="list-style-type: none"> • Mountain Sheep - \$250 • Mountain Goat - \$150 • Moose - \$125 • Elk - \$125 • Caribou - \$125 • Cougar - \$125 • Black Bear - \$75 • Deer - \$50 • Wolf - \$50



Before you start

Before you submit a permit to accompany report, make sure you have:

- An active Fish and Wildlife ID.
- A permit to accompany for which the hunt end date has passed.

Log in to your Fish and Wildlife profile from the B.C. Hunting homepage at www.gov.bc.ca/hunting.

Next, click on **Permit to Accompany** under **Reports** on the left-hand side of your profile home page.

- Click the **Create New** button to start a new report.

This report must be submitted by the permit holder (B.C. resident), whether the hunt takes place or not, within 10 days after the hunt end date authorized by the permit. Any applicable royalties due must be paid within 30 days after the hunt end date authorized by the permit.
