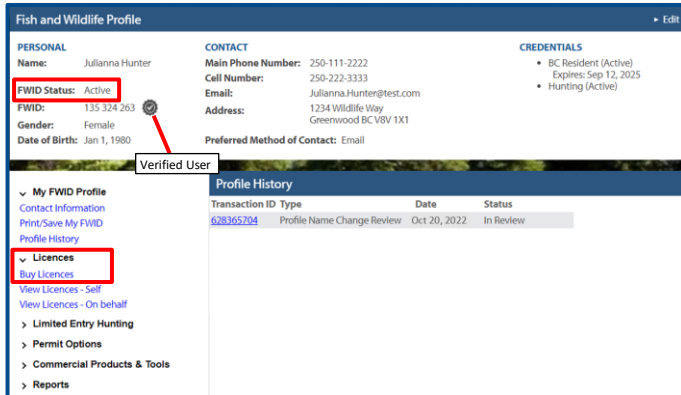


# Buy a Hunting and/or Species Licence on Behalf of an Adult

## Who can buy on behalf of an adult?

A resident hunter who holds a Permit to Accompany (PTA) can buy a hunting licence on behalf of a non-resident or non-resident alien who is named on the PTA. Species licences can also be bought on behalf of the hunter, for species listed on the PTA.

A licensed Guide Outfitter can buy on behalf of an adult client (all residency types).



**NOTE:** If you don't see a "Buy Licences" link, please check your profile has been verified

## Before you start

Before you buy on behalf of an adult, make sure you have:


- A verified, active **Fish and Wildlife ID**
- Credit card for payment

Make sure the adult you are buying for has:

- A verified, active **Fish and Wildlife ID**
- An active **residency credential**
- A **hunting credential** (depending on the licence type you want to buy for them)

From your (the person buying the licence) Fish and Wildlife profile:

- Click on **Buy Licences** under the **Licences** lefthand menu item



## Search for adult's profile

Click on **Buy Licence on Behalf of an Adult** – a pop-up box will appear:

- Enter the adult's FWID, last name and first initial
- Click **Search**
- Choose the **licence year** (if applicable)

**NOTE:** If you do not find the adult you are buying licences for, you will need to contact **FrontCounter BC** for assistance.

**ADD ANOTHER LICENCE**

**Hunters must carry photo ID and know or be able to produce their FWID number while hunting (Hunters under 16 years of age are not required to carry photo ID).**

There is no paper version of the Basic hunting licence or the Upland Gamebird licence. All species licences purchased for the current licence year must be carried at all times while hunting.

All species licences purchased online will be mailed to you and are subject to Canada Post standard delivery times.

Please note licences will only be mailed within Canada. You may qualify for a free replacement if you report at a FrontCounter BC or Service BC office within 15 to 30 business days from the date of purchase if you have not received your licences. You will be prompted to confirm your mailing details before you complete your purchase.

- Click the permission **attestation box**
- **Answer the Survey Question**
- Click **Add to Shopping Cart**
- You can then choose to buy another licence or click **Proceed to Checkout**

- From your Fish and Wildlife profile home page, click on **View Licences – On behalf** under the **Licences** lefthand menu item
- You can view licences you purchased on behalf of the adult

**NOTE:** The licence will also appear in the adult's profile, however, the adult will not be able to view the receipt.

*Hunting licences are electronic and do **not need to be printed**; however, hunters must carry all of their species licences for the current licence year with them while hunting. Hunters aged 16 and older must also carry photo ID to present to an officer on request.*
