





If a member of your group is not participating in the hunt, they must make sure that the HARVEST REPORT section of his/her authorization is up to date before joining in the hunt with the rest of the group, and prior to taking possession of or transporting any portion of an animal harvested under this Limited Entry Hunting authorization. Please keep this form - you do not need to return it.			

LEH Authorization (Shared)

- Each member in the Shared hunt must print off and carry their own **Harvest Report**
- Any special instructions for your hunt will be listed in the middle section of the authorization

NOTE: You must carry the Harvest Report portion of the authorization while you hunt. All members of the shared hunt **MUST** print and carry the Harvest Report. Once an authorized animal is harvested, the successful hunter must immediately inform the other members of the group, and each member of the group must immediately document the successful harvest on their Harvest Report Form.
