


# Royalty Payments

<b>Required when:</b>	Royalties for Permit to Accompany reports must be paid within 30 days after the Hunt End Date, or the day the report is submitted if that has already passed. Royalties for Guide Outfitter reports must be paid before March 31st of the following calendar year of the latest harvest date or the day the report is submitted if that has already passed.
<b>Who is eligible to pay?</b>	The holder of a Permit to Accompany or Guide Outfitter report.
