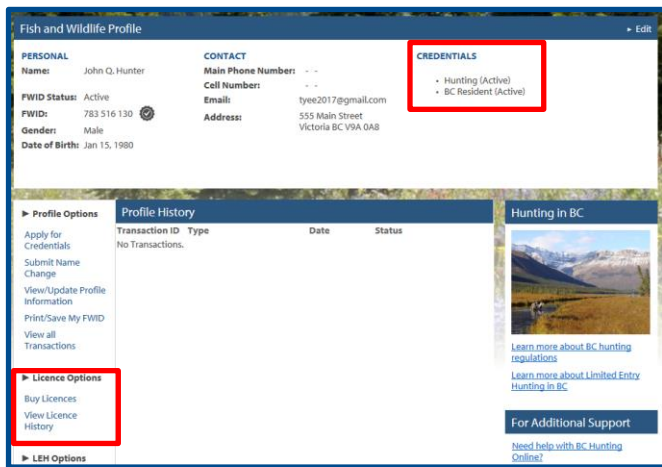


Buy a Licence on Behalf of a Youth

<p>What licences can I buy for a youth?</p>	<p>You can buy the following licences for a child or ward:</p> <ol style="list-style-type: none"> Youth licence Resident hunting licence Species licence
<p>Who can buy on behalf of a youth?</p>	<p>Parents or guardians who are 18 or older can purchase on behalf of a youth.</p>



Before you start

Before you buy on behalf of a youth, make sure **both you and your child/ward** have the following:

- An active Fish and Wildlife ID with verified user status

If you are buying a resident hunting licence or a species licence for a child, they must also have:

- Resident and hunting credentials

You will also need a credit card for payment

- Sign on to your Fish and Wildlife profile
- Click on **Buy Licences** under **Licence Options**
- On the next screen, click on **Buy licences on behalf of a youth**

NOTE: If you do not see a “Buy” button, please check your profile and eligibility to buy licences

Add a Licence for a Youth

Youth hunters must be at least 10 years of age and under 18. They must be a verified user with an active FWID. If you are purchasing a resident hunting licence on behalf of a Youth, the Youth must have resident and hunting credentials. Before selecting a licence, you must enter the Youth's FWID, Last Name, and First Initial and click SEARCH.

- Enter the youth's FWID number, last name and first initial and click **Search**
- If the profile is found, the youth's name will appear

Resident Hunting Licence (2016/17) ends March 31, 2017 v

A resident hunting licence is available to anyone at least 10 years of age and under 18, who is a verified user with an active FWID and active resident and hunting credentials. A parent/guardian must buy the licence on behalf of the Youth and must complete the Written Undertaking and attestation below before buying the licence. You can buy species licences on behalf of the Youth once you have added the Youth's resident hunting licence to your shopping cart.

The youth is not required to carry a paper version of this licence while hunting, but they must know their FWID number. Youths over 16 must carry photo ID while hunting.

Parent/Guardian Written Undertaking

You must complete this section before you can buy the licence.

I attest that I am the parent or legal guardian of the youth stated on this form. In accordance with the Wildlife Act, I undertake not to allow the youth named above to hunt or carry a firearm unless he or she is accompanied by and under the close personal supervision of a person who

- a. is 18 years of age or older,
- b. holds a hunting licence, other than an initiation hunting licence, or is exempted from holding a hunting licence, and
- c. meets all other qualifications, prescribed by regulation, that apply with respect to persons who many supervise hunters under 18 years of age.

Complete the written undertaking

Before buying a youth licence or a resident hunting licence on behalf of a youth, you must complete the written undertaking.

***NOTE:** If you are buying only species licences on behalf of a youth, you are not required to complete a written undertaking.*

- Click the **Sign Written Undertaking** button.
- Click the box to confirm that you intended to provide an electronic signature
- Click the **Add to Shopping Cart** button
- You can then choose to buy another licence or click the **Proceed to Checkout** button

Deer - Mule (2016/17) ends March 31, 2017

The youth must carry this species licence while hunting, along with identification (photo ID if they are 16 or older). They must also know their FWID number.

If the youth plans to hunt in the next few days, consider buying the species licences at any Service BC, FrontCounter BC or participating vendor location.

All species licences bought online will be mailed within 3 business days and are subject to Canada Post standard delivery times. You will be prompted to confirm your mailing details before you complete your purchase.

You have chosen a Deer - Mule Species Licence for the 2016/17 Licence Year, which has 24 days remaining. **Licence fee \$45.00**

Buying a species licences for a youth

NOTE: You can't buy a species licence for a youth if they do not have a resident hunting licence. Make sure you add their resident hunting licence to the shopping cart before you try to buy the youth a species licence.

- Choose the species licence you want to buy from the dropdown list
- Select the quantity of licences you wish to buy (applies only to species with a bag limit over 1)
- Click the **Add to Shopping Cart** button.
- You can then choose to buy another licence or click the **Proceed to Checkout** button

NOTE: Species licences bought on behalf of a youth will be mailed to the purchaser's address. If the youth resides at a different address, you can select a one-time shipping address. Only one shipping address can be used in a single transaction.

NOTE: Species licences bought online will be mailed to you, and may take between 4 and 15 business days to arrive. There is no option to pick up your licence at an in-person location. If you need your licence(s) right away, consider buying them in-person at Service BC, FrontCounter BC or a participating vendor location.


