

Training Tax Credits: Table of Eligible Programs and Completion Requirements for Employers

Income Tax Act

The table below shows the requirements for an employer to claim the training tax credit (TTC). The table includes the BC (non-Red Seal) programs and the interprovincial (Red Seal) programs.

Some of the programs listed below may not currently be active with the Industry Training Authority. To determine the status of a program, check with the Industry Training Authority at itabc.ca

Notes

1. An * beside the name of a program means that it is an interprovincial (Red Seal) program. BC does not provide a TTC for the first 24 months of these programs. A federal credit is provided by the federal government for the first 24 months of an interprovincial Red Seal program.

For example, if an employee is registered in the Industrial Mechanic program, TTCs are available for levels 3 and 4 (graduate program). The employer must apply to the federal government for the federal credit for the first 24 months of an interprovincial Red Seal program.

2. N/A means that there is no TTC available for the level shown.
3. Two ** beside N/A means that you may be eligible for the federal Apprenticeship Job Creation Tax Credit.
4. Three *** beside N/A means that the program is only for 12 months.
5. “Complete level ‘x’” means the apprentice must complete the technical training for that level. For example, “complete level 3” means complete level 3 of technical training for that program.

6. "Graduate program" means that you qualify for the tax credit level once your employee has received their Certificate of Qualification or Certificate of Apprenticeship.
