**SUBJECT: NATURAL GAS POSTED MINIMUM PRICE  
FOR THE MONTH OF August 2024**

The British Columbia Posted Minimum Prices (PMP) for raw and residue gas volumes made available for sale in the production month of **August** are as follows:

<u>Plant Group</u>	<u>\$/10<sup>3</sup>m<sup>3</sup></u>
Group 1 – Fort Nelson	10.000
Group 2 – McMahon	10.000
Group 3 – Pine River	10.000
Group 4 – Other BC	10.000
Group 5 – Alberta	10.000

The PMP are the lowest prices that may be used in both the determination of the Crown royalty rates and in the valuation of the Crown's royalty and freehold production tax shares.
