The British Columbia Posted Minimum Prices (PMP) for raw and residue gas volumes made available for sale in the production month of January are as follows:

<u>Plant Group</u>	<u>\$/10³m³</u>
Group 1 – Fort Nelson	10.000
Group 2 – McMahan	25.855
Group 3 – Pine River	10.000
Group 4 – Other BC	27.450
Group 5 – Alberta	27.028

The PMP are the lowest prices that may be used in both the determination of the Crown royalty rates and in the valuation of the Crown's royalty and freehold production tax shares.
