The British Columbia Posted Minimum Prices (PMP) for raw and residue gas volumes made available for sale in the production month of July are as follows:

<b>Group 1 – Fort Nelson</b>	<b>67.687</b>
<b>Group 2 – McMahan</b>	<b>94.890</b>
<b>Group 3 – Pine River</b>	<b>70.543</b>
<b>Group 4 – Other BC</b>	<b>89.060</b>
<b>Group 5 – Alberta</b>	<b>92.573</b>

The PMP are the lowest prices that may be used in both the determination of the Crown royalty rates and in the valuation of the Crown's royalty and freehold production tax shares.
