**SUBJECT: NATURAL GAS POSTED MINIMUM PRICE  
FOR THE MONTH OF November 2024**

The British Columbia Posted Minimum Prices (PMP) for raw and residue gas volumes made available for sale in the production month of **November** are as follows:

<b>Group 1 – Fort Nelson</b>	<b>24.190</b>
<b>Group 2 – McMahon</b>	<b>10.000</b>

<b>Group 4 – Other BC</b>	<b>10.000</b>
<b>Group 5 – Alberta</b>	<b>10.000</b>

The PMP are the lowest prices that may be used in both the determination of the Crown royalty rates and in the valuation of the Crown's royalty and freehold production tax shares.
