

INSTRUCTIONS FOR COMPLETING THE APPLICATION FOR REFUND OF CARBON TAX GREENHOUSE GROWERS – SELLER (PROPANE)

under the Carbon Tax Act April 1, 2024 to March 31, 2025

GENERAL INFORMATION

We must receive your refund application within four years from the date you paid the security.

For more information, see our **Partial exemption from carbon** tax for greenhouse growers page.

WHO SHOULD USE THIS FORM?

Use this form to apply for a refund if you are a deputy collector or retail dealer who sold propane partially exempt from carbon tax to an eligible greenhouse grower. You can use this application form for more than one sale. For example, sales to multiple eligible greenhouse growers.

If you are a natural gas retail dealer, you must claim your natural gas refunds on your Carbon Natural Gas Tax Return through your CNG account in eTaxBC.

If you are an eligible greenhouse grower who paid carbon tax at the full applicable rate on fuel used for an eligible purpose, you must complete the Application for Refund of Carbon Tax Greenhouse Growers – Purchaser (FIN 110A). See our Motor fuel tax and carbon tax forms page for the appropriate version of the form.

Note: We cannot issue a total refund of less than \$10.

PART A - CLAIMANT INFORMATION

Full Legal Name

Enter the full legal name of the claimant who paid the security.

An operating name or "doing business as" name may not be the legal name. If the claimant is a corporation, enter the name as it appears on the incorporation certificate. If the claimant is a proprietorship, the legal name is the legal name of the individual who owns the business.

Business Number

Enter your 9-digit business number provided by Canada Revenue Agency, if you have one.

Mailing Address

Enter your complete mailing address. If applicable, a cheque and/or a refund decision letter will be mailed to this address. This address should not be the address of a third-party representative, such as an external accountant, bookkeeper or consultant.

Contact Name and Contact Telephone Number

Enter the name and telephone number of a person to contact if the ministry has questions about this application.

PART B - REFUND INFORMATION

Claim Period

On this application form you may only claim a refund of security you paid on fuel that you have sold on or after April 1, 2024 until March 31, 2025.

Line 1:

Enter the total litres of propane sold to eligible greenhouse growers.

PART C - CLAIMANT DECLARATION

If the claimant is a corporation, the declaration must be signed by a member of the board of directors or an authorized employee of the corporation. Type or print the name and title of the person who is signing the declaration.

Only the individual or business who paid the security can claim the refund. For more information, see our **Refunds for motor fuel tax and carbon tax** page.

SUBMITTING YOUR APPLICATION

Send the completed application, along with the supporting documentation (as indicated in Part B under the Documents to Attach and detailed in the section Explanation of Document Numbers on Page 2), to:

Keep a copy of this application and supporting documents for your records.

Note: Submitting supporting documents on a USB flash drive will assist with processing your refund application.

AFTER YOU APPLY

When reviewing your claim, we may ask you to provide additional information or supporting documentation.

We may also ask you to include proof of payment, such as credit or debit card statements, or a statement of account from the seller showing payment of the invoice. Payment details from your own accounting records (e.g. your cash and accounts payable journals) are not accepted as proof of payment.

Note: Electronic Funds Transfer documents and third-party payment system documents must show the name of the payee.

If you do not provide additional supporting documentation or proof of payment on request, your refund request may be disallowed.

EXPLANATION OF DOCUMENT NUMBERS

Do not submit original documents with your application. Ensure copies are legible. We may request additional information or documentation if required.

- 1 A schedule of eligible wholesale fuel purchases in B.C. during the claim period showing the date of the purchase, the name of the fuel supplier, the fuel type, the rate of carbon tax, and the quantity of fuel purchased.
- 2 A schedule of fuel sales included in the refund claim showing the date of the sale, the name of the purchaser, and the type and the quantity of fuel sold partially exempt from carbon tax.
 - **Note:** For assistance in preparing a schedule of fuel purchases or a schedule of fuel sales, an **Excel Schedule Template** is available on our website with the suggested formats.
- 3 Copies of the fuel purchase invoices showing the name and address of the fuel seller and the purchaser, the date of purchase, the quantity of fuel purchased, the type of fuel and the rate of tax. You can submit copies of the fuel purchase invoices with the claim or upon request when the claim is verified.

- 4 Copies of the sales invoices showing the date of the sale, the name of the purchaser, the type and quantity of fuel sold, and the invoice total. You can submit copies of the fuel sales invoices with the claim or upon request when the claim is verified.
- 5 Copies of the Certificates of Partial Exemption Greenhouse Growers (FIN 463) that have been completed by the eligible greenhouse growers.
- 6 If you are applying as an individual or a sole proprietorship, include a copy of your photo ID as evidence to support your legal name (e.g. a copy of your driver's licence, passport or other governmentissued ID).

If you are a corporation not registered in B.C., submit a copy of your incorporation certificate.
