Freedom of Information and Protection of Privacy Act (FOIPPA) The personal information on this form is collected for the purpose of administering the Tobacco Tax Act under the authority of section 26(a) of the FOIPPA.

PART A - GENERAL INSTRUCTIONS

- Effective April 1, 2018: the tobacco tax rate will increase by 2.8 cents to 27.5 cents per cigarette and by 12.8 cents to 37.5 cents per gram for all tobacco other than cigars and cigarettes.
All tobacco retail dealers: must complete this inventory return and calculate the tax increase on any inventory in stock at the end of day March 31, 2018.
Consolidate return: complete only one retail dealer's inventory return per legal entity.
Due date: this return and payment (if required) must be filed by April 30, 2018.
Tobacco included in inventory: you must report all tobacco (excluding cigars and tax-exempt/black stock) on the premises and any other location where you store tobacco products.
Cigars: do not include cigars in your inventory count.
Commission: deduct a commission of 5% if you file and pay on-time.
Filing and payment options: eTaxBC, Mail, In person: Service BC Centres.
